### BRIEF DETAILS OF THE TREATMENT FACILITY

The various waste are segregated at the point of generation and kept in colour coded bins with bio-degradable bags containing bleaching solution and covered .After 24 hours each bag collected by the sweeper and weighed in the presence of supervisor (Smt.Suprava Mahanta,Staff Nurse I/C) and finally shifted the containment area store room and these items are shifted by a outsourcing agency name "Madiade Marketing,Bhubaneswar" selected by CDMO,Keonjhar for shifting the waste within 48 hours.

The mutilated plastics which are kept a blue bins in bleaching solution are kept in a closed area to be shifted to outsourcing agency.
